Vyepti® (eptinezumab)

DOSING AND ADMINISTRATION



Vyepti® is indicated for the preventive treatment of migraine in adults1

HOW TO DILUTE

- Vyepti requires dilution before administration.¹
- Vyepti is a clear to slightly opalescent, colourless to brownish-yellow solution.¹
- Inspect vial visually for particulate matter and discolouration before use do not administer if the Vyepti contains visible particulate matter or is cloudy or discoloured.1

RECOMMENDED DOSE

To prepare Vyepti 100 mg¹

- Withdraw 1 mL of Vyepti from a single-dose vial using a sterile needle and syringe.
- Inject the 1 mL Vyepti into a 100 mL bag of 0.9% sodium chloride injection.
- Do not use any other diluents.

To prepare Vyepti 300 mg dose¹

- Withdraw 1 mL from each of three singledose vials using a sterile needle and syringe.
- Inject the 3 mL Vyepti into a 100 mL bag of 0.9% sodium chloride injection.
- Do not use any other diluents.



Use appropriate aseptic technique when preparing Vyepti solution for intravenous (IV) infusion.



After dilution, Vyepti must be infused as soon as practicable and within 8 hours. Until infusion, the solution can be kept at room temperature (20–25°C) or refrigerated (2–8°C). Do not freeze. If refrigerated, allow the solution to come to room temperature before infusing.¹

Vyepti single-dose vials contain no preservative; discard unused product in the vial.¹

HOW TO ADMINISTER INFUSIONS

- DO NOT administer Vyepti as an IV push or bolus injection.¹
- (!) **DO NOT** mix Vyepti with any other medications or administer any other medication through the infusion set.¹

Use an IV infusion set with a 0.2 or 0.22 µm in-line or add-on sterile filter to administer Step 1 the diluted Vyepti solution intravenously.1

Step 2 Infuse over 30 minutes to administer the whole dose.¹

Step 3 When complete, flush the line with 20 mL of 0.9% sodium chloride solution. The treating physician should observe or monitor patients during and after the infusion in accordance with normal clinical practice.1



One 30-minute infusion every 12 weeks¹

POST-INFUSION

Schedule three-monthly (12-weekly) appointments for ongoing treatment.¹
